

Privacy Policy

McBride Orthopedic Hospital (the “Company”, “We”, “Us”, or “Our”) respect Your privacy and are committed to protecting it through Our compliance with this privacy policy (the “Privacy Policy”).

This Privacy Policy describes the types of information We may collect from You or that You may provide when You visit the Website; outlines Our policies and procedures for the collection, use, maintenance, protection, and disclosure of Your information when You use the Website; and tells You about Your privacy rights and how the law protects You.

We use Your Personal Data to provide and improve the Website. Please read this Privacy Policy carefully to understand Our policies and procedures regarding Your information and how We will treat it. If You do not agree with Our policies and procedures, Your choice is not to use the Website. By accessing or using this Website, You agree to this Privacy Policy.

Interpretation and Definitions

Interpretation. The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions. For the purposes of this Privacy Policy:

- Account means a unique account created for You to access Our Website or parts of Our Website.
- Business refers to the Company as the legal entity that collects Consumers’ personal information and determines the purposes and means of the processing of Consumers’ personal information, or on behalf of which such information is collected and that alone, or jointly with others, determines the purposes and means of the processing of consumers’ personal information, including a business that does business in the relevant State.
- Consumer means a natural person who is a State resident. A resident, as defined in the law unless defined differently in a specific State law, includes (1) every individual who is in the USA for other than a temporary or transitory purpose, and (2) every individual who is domiciled in the USA who is outside the USA for a temporary or transitory purpose.
- Cookies are small files that are placed on Your computer, mobile device, or any other device by a website, containing the details of Your browsing history on that website among its many uses.
- Device means any device that can access the Website such as a computer, a cellphone, or a digital tablet.
- Do Not Track (“DNT”) is a concept that has been promoted by U.S. regulatory authorities, in particular the U.S. Federal Trade Commission (FTC), for the Internet industry to develop and implement a mechanism for allowing internet users to control the tracking of their online activities across websites.
- McBride Orthopedic Hospital (the “Company”, “We”, “Us”, or “Our”) refers to the company located at 9600 Broadway Ext., Oklahoma City, OK 73114.
- Personal Data is any information that relates to an identified or identifiable individual, or as specifically defined under a State law.
- Sale means selling, renting, releasing, disclosing, disseminating, making available, transferring, or otherwise communicating orally, in writing, or by electronic or other means, a Consumer’s personal information to another business or a third party for monetary or other valuable consideration, or as specifically defined under a State law.

- Service Provider means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Website, to provide the Website on behalf of the Company, to perform services related to the Website or to assist the Company in analyzing how the Website is used.
- State means a State of the United States of America.
- Third-party Social Media Service refers to any website or any social network website through which a user can log in or create an account to use the Website.
- Usage Data refers to data collected automatically, either generated by the use of the Website or from the Website infrastructure itself (for example, the duration of a page visit).
- Website refers to McBride Orthopedic Hospital website, accessible from <https://mcboh.com/>.
- You ("Your") refers to the individual accessing or using the Website, or the company, or other legal entity on behalf of which such individual is accessing or using the Website, as applicable.

Collecting and Using Your Personal Data

Types of Data Collected:

Directly Provided Data. While using Our Website, We may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You. Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Phone number
- Address, State, Province, ZIP/Postal code, City

The information We collect on or through Our Website may also include records and copies or Your correspondence if You contact Us.

Usage Data. Usage Data is collected automatically when using the Website and may include personally identifiable information and information such as Your Device's Internet Protocol address (IP address), browser type, browser version, the pages of our Website that You visit, the time and date of Your visit, the time spent on those pages, unique device identifiers and other diagnostic data. When You access the Website by or through a mobile device, We may collect certain information automatically, including, but not limited to, (1) the type of mobile device You use, (2) Your mobile device unique ID, (3) the IP address of Your mobile device, (4) Your mobile operating system, (5) the type of mobile Internet browser You use, (6) unique device identifiers and other diagnostic data. We may also collect information that Your browser sends whenever You visit Our Website or when You access the Website by or through a mobile device.

Tracking Technologies and Cookies. We use Cookies and similar tracking technologies to track the activity on Our Website and store certain information. Tracking technologies used are beacons, tags, and scripts to collect and track information and to improve and analyze Our Website. The technologies We use may include:

- **Cookies or Browser Cookies.** A cookie is a small file placed on Your Device. You can instruct Your browser to refuse all or some Cookies or to indicate when a Cookie is being sent, but if You do not accept Cookies, You may not be able to use all or parts of the Website. Unless You have adjusted Your browser setting so that it will refuse Cookies, Our Website may use Cookies. If You disable or refuse Cookies, please note that some parts of this Website may then be inaccessible or not function properly.

- **Web Beacons.** Certain sections of Our Website and Our emails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the Company, for example, to count users who have visited those pages or opened an email and for other related website statistics (for example, recording the popularity of a certain section and verifying system and server integrity).

Cookies can be “Persistent” or “Session” Cookies. Persistent Cookies remain on Your personal computer or mobile device when You go offline, while Session Cookies are deleted as soon as You close Your web browser. You can learn more about cookies here: All About Cookies by TermsFeed. We use both Session and Persistent Cookies for the purposes set out below:

- **Necessary / Essential Cookies**
Type: Session Cookies
Administered by: Us
Purpose: Provide You with services available through the Website, enable You to use Website features, help authenticate users, prevent fraudulent use of user accounts required to provide You the Website.
- **Cookies Policy / Notice Acceptance Cookies**
Type: Persistent Cookies
Administered by: Us
Purpose: Identify if users have accepted the use of Cookies on the Website.
- **Functionality Cookies**
Type: Persistent Cookies
Administered by: Us
Purpose: Allow Us to remember choices You make when You use the Website, e.g., remembering login details or language preference. Avoid You having to re-enter Your preferences every time You use the Website.
- **Tracking and Performance Cookies**
Type: Persistent Cookies
Administered by: Third Parties
Purpose: Used to track information about traffic to the Website and how users use the Website. The information gathered via these Cookies may directly or indirectly identify You as an individual visitor. This is because the information collected is typically linked to a pseudonymous identifier associated with the device You use to access the Website. We may also use these Cookies to test new pages, features or new functionality of the Website to see how Our users react to them.

Use of Your Personal Data. The Company may use Personal Data for the following purposes:

- **To provide and maintain Our Website,** including monitoring the usage of Our Website.
- **To manage Your Account:** to manage Your registration as a user of the Website and give You access to different functionalities of the Website that are available to You as a registered user.
- **For the performance of a contract:** the development, compliance and undertaking of the contract for the products, items, or services You have purchased or any other contract through the Website.

- **To contact You:** To contact You by email, telephone calls, SMS, or other equivalent forms of electronic communication, such as a mobile application's push notifications regarding updates or informative communications related to the functionalities, products, or contracted services, including the security updates, when necessary or reasonable for their implementation.
- **To provide You** with news, special offers and general information about other goods, services, and events which We offer that are similar to those that You have already purchased or enquired about unless You have opted not to receive such information.
- **To manage Your requests:** To attend and manage Your requests to Us.
- **For business transfers:** To evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all Our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Data held by Us about Our Website users is among the assets transferred.
- **For other purposes:** Such as data analysis, identifying usage trends, determining the effectiveness of Our promotional campaigns and to evaluate and improve Our Website, products, services, marketing, and Your experience.

We may share Your Personal Data in the following situations:

- **With Service Providers:** To monitor and analyze the use of Our Website or to contact You.
- **For business transfers:** To a buyer or other successor in connection with, or during negotiations of, any merger, divestiture, reorganization, dissolution, sale of Company assets, financing, or any other sale or transfer of all or a portion of Our business to another company, whether as a going concern or as a part of bankruptcy, liquidation, or similar proceeding, in which personal information held by the Company about our Website users is among the assets transferred.
- **With affiliates:** In which case We require affiliates (including Our parent company and any other subsidiaries, joint venture partners or other companies that We control or that are under common control with Us) to honor this Privacy Policy.
- **With business partners:** To offer You certain products, services, or promotions.
- **With other users:** when You share personal information or otherwise interact in the public areas with other users, such information may be viewed by all users and may be publicly distributed outside. If You interact with other users or register through a Third-Party Social Media Service, Your contacts on the Third-Party Social Media Service may see Your name, profile, pictures, and description of Your activity. Similarly, other users will be able to view descriptions of Your activity, communicate with You and view Your profile.
- **With Your consent:** For any other purpose with Your consent.

Residents of certain states, such as California, Colorado, Connecticut, Delaware, Florida, Indiana, Iowa, Montana, Oregon, Texas, Utah, and Virginia, may have additional personal information rights and choices. Please see the ["Your State Privacy Rights"](#) section below for more information.

Retention of Your Personal Data. The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with Our legal obligations (for example, if We are required to retain Your data to comply with applicable laws), resolve disputes, and enforce Our legal agreements and policies. The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period, except when this data is used to strengthen the security or to improve the functionality of Our Website, or We are legally obligated to retain this data for longer time periods.

Transfer of Your Personal Data. Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to, and maintained on, computers located outside of Your state, province, country, or other governmental jurisdiction where the data protection laws may differ than those from Your jurisdiction. Your consent to this Privacy Policy followed by Your submission of such information represents Your agreement to that transfer. The Company will take all steps reasonably necessary to ensure that Your data is treated securely and in accordance with this Privacy Policy and no transfer of Your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of Your data and other personal information.

Disclosure of Your Personal Data.

Business Transactions. If the Company is involved in a merger, acquisition or asset sale, Your Personal Data may be transferred. We will provide notice before Your Personal Data is transferred and becomes subject to a different privacy policy.

Law enforcement. Under certain circumstances, the Company may be required to disclose Your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g., a court or a government agency).

Other legal requirements. The Company may disclose Your Personal Data in the good faith belief that such action is necessary to:

- Comply with a legal obligation
- Protect and defend the rights or property of the Company
- Prevent or investigate possible wrongdoing in connection with the Website
- Protect the personal safety of users of the Website or the public
- Protect against legal liability

Security of Your Personal Data. The security of Your Personal Data is important to Us but remember that no method of transmission over the Internet or method of electronic storage is 100% secure. While We strive to use commercially acceptable means to protect Your Personal Data, We cannot guarantee its absolute security.

Detailed Information on the Processing of Your Personal Data. The Service Providers that We use may have access to Your Personal Data. These third-party vendors collect, store, use, process, and transfer information about Your activity on Our Website in accordance with their Privacy Policies.

Analytics. We may use Service Providers to monitor and analyze the use of Our Website, e.g., Google Analytics, a web analytics service offered by Google that tracks and reports website traffic and uses data collected to track and monitor the use of Our Website and share data with other Google services. Google may use the collected data to contextualize and personalize the ads of its own advertising network. Email Marketing. We may use Your Personal Data to contact You with newsletters, marketing or promotional materials and other information that may be of interest to You. We may use the Service Provider Constant Contact to manage and send emails to You. Behavioral Remarketing. The Company may use remarketing services to advertise to You after You have accessed or visited Our Website.
